This information can include: • Social Security number Credit history Payment history • Overdraft history • Transaction history • Mortgage rates and payments When you are *no longer* our customer, we continue to share your information as described in this notice. How? All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Hilltop Bank chooses to share; and whether you can limit this



How does Hilltop Bank protect my personal nformation?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.	
How does Hilltop Bank collect my personal information?
